VENDOR RULES & REGULATIONS

MAY 27-29, 2022

This agreement is between Legends Casino Hotel Pow Wow Committee and the authorized person(s) on application, hereinafter to be known as the Vendor. The Vendor lease on the space will be subject to the following specifications: All vendors must complete and sign the Vendor Application Form. **All payments must be prepaid in full and sent in with the application. No applications will be accepted after April 29, 2022.**

Acceptable forms of payments: Cashiers Checks or Money Orders made payable to Yakama Nation Legends Casino Hotel and accompany your application. No cash, personal checks, debit or credit cards will be accepted.

Vendor Booth Fees: Material/Craft Vendors \$300 and Food/Drink Vendors \$400. Vendors will not be allowed to walk around and sell items to spectators and/or participants.

Vendor Set-up: Thursday, May 26 | 8am-8pm and Friday, May 27 | 8am-2pm. Vendors will not be accepted after 2pm on Friday, May 27, 2022.

Weather: LCH Pow Wow will be an outdoor event. No refunds shall be made as a result of bad weather. Vendors should be prepared for inclement weather and protections of their booth set-up.

Power: Vendors must be responsible for providing, setting up and maintaining their own equipment and power source.

Fire Extinguisher: Vendors must have an approved fire extinguisher must be accessible and located within the booth area.

Vendor Spaces: are limited and will be issued after applications have been reviewed by a first come first serve basis, according to the date the Vendor fees have been paid. If you are accepted as a Vendor you will receive a copy of the signed application with your confirmation. A max of 4 workers in the booth during the event.

Artisan Vendors: please, be in compliance with the Indians Arts and Crafts Act of 1990 (P.L.101-644), which prohibits misrepresentation in marketing of Indian arts and crafts products within the United States. The Indian Arts and Crafts Act of 1990 is a truth-in advertising law. It is illegal to offer or display for sale, or sell any art or craft product in a manner that falsely suggests it is Indian produced, an Indian product, or the product of a particular Indian Tribe.

Food Vendors: all workers must have proof of a valid food handlers card. Vendors will need to adhere to all food handling regulations and wear proper attire to ensure the safety and health of all consumers. Vendors with a self-contained "kitchen" are responsible for clean work areas at all times. All food Vendors will be subject to a Health Inspection. No refunds will be made as a result of an unfavorable inspection.
