## POW WOW & STICK GAME TOURNAMENT VENDOR RULES & REGULATIONS MAY 19-21,2023

This agreement is between Legends Casino Hotel Pow Wow Stick Game Committee and the authorized person(s) on the application, hereinafter to be known as the vendor. The vendor lease on the space will be subject to the following specifications: All vendors must complete and sign the Vendor Application Form. **All payments must be prepaid in full and sent in with the application. No applications will be accepted after May 5, 2023.** 

**Acceptable forms of payments:** Cashiers Checks or Money Orders made payable to Yakama Nation Legends Casino Hotel and must accompany your application. No cash, personal checks, debit or credit cards will be accepted.

**Vendor Booth Fees:** Merchandise/Craft vendors \$350 and Food/Drink vendors \$500. Vendors will not be allowed to walk around and sell items to spectators and/or participants.

**Vendor Set-up:** Thursday, May 18, 2023 1pm-8pm and Friday, May 19, 2023 8am-2pm. Vendors will not be accepted after 2pm on Friday, May 21, 2023.

**Weather:** This will be an outdoor event, no refunds shall be made as a result of bad weather. Vendors should be prepared for inclement weather, be sure to protect and secure your booth set-up.

**Power:** Vendors must be responsible for providing, setting up, and maintaining their own equipment and power source. Generators are allowed, please note on application if you will be running a generator.

**Fire Extinguisher:** Vendors must have an approved fire extinguisher accessible and located within the booth area at all times.

**Vendor Spaces:** are limited and will be issued after applications have been reviewed by a first come first serve basis, according to the date the vendor fees have been paid. If you are accepted as a vendor you will receive a copy of the signed application with your confirmation. A max of 4 workers are allowed in the booth during the event.
