OFFICIAL PROMOTIONAL RULES

High Hand Bash

This promotion will replace the High Hand Special and any other new promotions that may be applicable for this day.

Top 27 Players who logged the most hours of Live Texas Hold'em will have a guaranteed seat to play live action Texas Hold'em on the date specified below. Hours will be displayed and updated daily by Poker Manager or Dual Rate Supervisor.

The promotion will run from 5pm-2am and the high hand prize amount will be awarded at the following times:
5pm: \$500 • 6pm: \$500 • 7pm: \$500 • 8pm: \$500 • 9pm: \$500 • 10pm: \$500 • 11pm: \$500 • 12am: \$500 • 1am: \$500 • 2am: \$500

Both Hole Cards must play, may not tie the board, and must be the winning hand to qualify. All Texas Hold'em games Class II are eligible. Minimum of \$10 in the main pot. Must see a Flop to be eligible. Minimum of 5 players dealt in minimum of \$2 for PSJ drop. Minimum of \$1 for revenue.

Each qualifying High Hand will be tracked (written) on a dry erase board near the poker podium by a floor supervisor for each hour and will be visible to all guests. Patrons will have a 15 minute time limit to claim each eligible High Hand prize awarded per hour or the unclaimed prize award amount will be forfeited. Any prize award amount forfeited will not progress to the next hour.

In the event there is no game or no qualified high hand during any designated high hand hour, the prize money will not be progressive over to the next hour and shall not be awarded.

Each live Texas Hold'em game will have to be in play for at least a ½ hour into each hour to be eligible for this promotion.

This promotion will be on 1 Table up to 3 Tables maximum and will compete with each other with each designated hourly high hand to be awarded.

Live play starts at 4pm on each monthly designated date and the top 27 players will need to check-in in person at the Poker Room from 3pm-4pm to guarantee their seat. At 4:01pm if any of the top 27 players have not checked in, their seat will be given to the next person signed up.

In the event that there are multiple patrons that have the same amount of hours at the 27th spot, then it becomes first come first serve for one of them to check-in from 3pm-4pm to have a 4pm seat. The remaining will be placed at the top of the waiting list as long as they checked in from 3pm-4pm.

Hours logged will be recorded in .25 increments per session played. If patron plays multiple sessions in a gaming day, each session will be recorded separately a minutes played will not be combined. : **.25 equals 15 minutes:** 00-09min = 0 • 10-24 min = .25 • 25-39 min = .50 • 40-54 min = .75 • 55-60 min = 1hr

In the event of more than 1 patron having the same high hand for the hour, the prize amount will be evenly distributed to each qualifying patron.

Patron may win more than 1 High Hand throughout the time frame of the promotion. All prize amounts will be paid out in money. All rules apply.

Dealer will notify Supervisor of each qualifying High Hand that has met the minimum requirement to be verified before the pot is pushed to the patron of the winning hand. The Bad Beat jackpot will not be eligible during this promotion for Class II Texas Hold'em.

Reconciliation of High Hand Bash

- Daily reconcile the amount indicated on the progressive sign/meter to the cash counted or received by the cage and the payouts made for each promotional progressive pot and pool. This reconciliation must be sufficiently documented, including substantiation of difference and adjustments.
- At least monthly, review all payouts for the promotional progressive pots, pools, or other promotions to verify payout accuracy and proper accounting treatment and that they are conducted in accordance with conditions provided to the patrons.
- At the conclusion of each contest/tournament, reconcile all contest/tournament entry and payout forms to the dollar amounts recorded in the appropriate accountability document.
- All prized awarded through this promotion will be aggregated in secure database by the Finance department. If the calendar year aggregated value is \$600 or more, a form 1099-MISC will be issued by Finance. Promotional prize payout information sheets will be forwarded to and retained by Finance and compliance and made available to the Tribal Gaming Agency upon request.

Winning patron will need to have valid ID to payout of any promotion/tournament: Valid State ID, Tribal ID, Military ID • Valid Social Security Number • W-9. For Non-Resident Aliens: Valid foreign country's driver license or identification card • Valid alien registration card • Valid passport or visa other U.S. Federally issued photo ID evidencing nationality and place of residence.

Team members of Legends Casino Hotel are not eligible for this promotion.

The licensed gaming establishment shall put forth its best efforts to resolve customer disputes fairly and equitably and, in a manner, which does not conflict with these Regulations. The licensee shall submit patron dispute procedures to TGA for approval. Personnel employed in gaming areas shall be instructed in the procedures to minimize and resolve player disputes. In the event a dispute with a player cannot be resolved, the licensee is obligated to inform the player that a complaint may be filed with TGA and shall inform the player that they may speak with the on-duty TGA representative to file a complaint. If the player elects to speak to the agent, the licensee must immediately notify the on-duty TGA representative.

Any immediate family member of a Team Member conducting a gaming promotion may participate as long as another, unrelated Team Member at a higher or separate position level activates their participation. For example, if a family member of a representative wants to participate, a supervisor/manager would need to authorize it. If a family member of a supervisor/manager wants to participate, then the Casino shift manager would need to authorize it. Family members are identified as: spouses, domestic partners, parents, grand- parents, siblings, children, in-laws, step-family, foster family, and persons regularly living in the same household.
